CAMPAIGN FAQs

1. What is “SINGURA NA AMITY” Promotion?

This is a 60 day transact and win Amity Realtors Ltd promotion open to all Ugandans (past, current and non customers of Amity Realtors Ltd) aged 18 years and above. Any individual who (1) purchases a plot of land from any of our estates, (2) settles an outstanding debt or buys a voucher via Airtel pay or MTN Mobile money prompts at Shs 5,000/ stands a chance to win a titled plot of land, a motorbike or a fully paid 5 days trip for 2 to Dubai. In addition, the promotion which is organised in partnership with Simba Automotives (U) Ltd will involve exciting Q & A sessions across select radio stations in Mbararaas an avenue for callers to win cash.

2. How do i qualify?

3. How many offers are available to be won?

The available offers include 3 titled plots of land (measuring 50ft by 100ft each), 2 motorbikes, fully paid 4 days trip to Dubai for two and cash prizes that will be won through weekly Q & A sessions.

4. What will the Dubai trip include?

The Dubai trip is a 4 days, 3 nights experience that will be won by 1 lucky winner who will then choose one other person to travel with for the trip. The offer will include return tickets for the two people, VISAS, accommodation on a full-board basis, airport pickups and drop offs, and activities that will include a city tour a desert safari tour.

CAMPAIGN TERMS AND CONDITIONS

A) The Organiser of the Promotion.

The Organizer is a limited liability company in accordance with the Laws of Uganda and approved by the National Lotteries and Gaming Regulatory Board to run the promotion.

C) Location

Mbarara City, Uganda

D) Time frame of the Promotion.

The Promotion will last for a duration of sixty four (60) days from 8th November, 2024 until the 10th January, 2025.

E) Acceptance of Terms of Use

- By purchasing a plot of land, settling an existing debt or purchasing a voucher through our designated Airtel pay and MTM MoMo merchant codes, the participant accepts to participate in the Promotion.
- The Organizer reserves the right to cancel or review the Promotion or these Terms and Conditions at any time.
- In the event of a dispute regarding these Terms and Conditions, conduct, results, and all other matters relating to the Promotion, the decision of the Organizer shall be final and no further correspondence or discussion or negotiation shall be entered into pertaining such a dispute.

- A Winner will be called only 3 (three) times in case they win and are out of reach.
- The Winner will be given 3 (three) days to show up for the Promotion.
- A Winner should have valid Identification Documents when they come to claim the Prize.
- The Winner shall come with the winning mobile number to enable the Organizer to make a confirmatory call to the number.
- The name that appears on the Identification Document will take precedence in case of variance in names.

- The exact date and place of the hand-over of the prizes shall be held at Head Office
